DIRECTOR'S STATEMENT

Dear PorchLight Community,

In 2022, we celebrated PorchLight's first anniversary of service to our community. We have begun to witness the immense impact our Family Justice Center has had on those we serve. No longer do we have to look towards research and examples from other communities about the importance of centralizing services, rather, our exit surveys from our Guests paint a clear picture of the immense benefit PorchLight and its network of dedicated professionals create every day. Survivors indicate that they feel safer, more informed, and heard, with a plan and pathway forward because of the support they receive at PorchLight.

Stepping into 2022 was full of new challenges for PorchLight. We were faced with what has become known as "the new normal" of adjusting to a post-COVID world. The ability to safely hold in-person events allowed PorchLight to host our First Annual Be the Light Gala, where community members, partners, volunteers, and friends gathered for an evening of support for PorchLight and raised over \$20,000. Our very first Gala was a huge success and laid a foundation of support for years to come. Additionally, we saw an increase in utilization of the Center as we went from serving an average of 7.5 Guests per day in 2021 to ending 2022 with an average of 13.8 Guests per day.

In 2017, PorchLight was just an idea. To sit here today and reflect upon all we have accomplished is humbling and inspiring. To all who have contributed in both big ways and small, we are so grateful. We are excited to continue building on this foundation in 2023, with opportunities to grow our team, bring in new partnerships, and continue to amplify and lift survivors' voices in Jefferson and Gilpin counties.

Our mission is to bring together essential services for victims, survivors, and their children to create a positive pathway forward, and to foster public safety.

GUEST STORY

Looking back, Jill* realized that she had spent half her life in abusive relationships. Ten years with her son's biological father and ten years with her now ex-husband. Jill was 17 years old and pregnant when she moved out of state with her boyfriend. She endured years of emotional, physical, and sexual abuse. She finally found the strength to leave when she became concerned for her son's safety.

Jill moved back to Colorado with her son to start a new life. Shortly after Jill relocated to Colorado, the father of her son found out where she lived and began stalking her. "He made my life a living hell. He told me that he was going to burn the house down with me in it." When Jill reached out for mental health services for her son, a therapist suggested Jill contact PorchLight. "I would never have known (about PorchLight) without Jefferson Center saying something." Jill had no idea what PorchLight was about, "I thought it was like therapy, but it was so much more."

A PorchLight Navigator connected Jill with several partner agencies, including legal advocacy and outreach programs. They were able to help Jill with a grant for legal fees, and funding so she and her son could move into a new place, a safe place. In addition to helping Jill secure the critical resources she needed, PorchLight's partner was able to provide Christmas gifts for her and her son. Jill recalls how she felt before she came to PorchLight, "I was in a dark place, stressed out, I was drinking all the time" "It's hard to know when you're ready to leave...but if more people knew what is available, I think they would".

Jill's healing journey has not been easy, but with support and determination, Jill has come a long way since those dark days, "I haven't had a drink since the beginning of the year. I have sole custody of my son, I'm divorced. I'm doing great!" "I don't think I could have done it without you all. You are beautiful people, beautiful souls." "There are no words to express how grateful I am for PorchLight."


